### **SUMMARY OF PROPOSED BUDGET FY2019:**

Meeting Date: Thursday, February 1, 2018

Business Manager Karen Smith discussed/outlined a summary of the preliminary Proposed Budget for FY2019 as follows:

General Fund – Appropriation: \$21,528,331 (prior to benefits).

- This figure is an increase of 2.9%, for an amount of \$616,360, over the FY2018 budget of \$20,911,971.
- The majority of the budget increase is to cover the cost of wages & union contract related increases. There is also an increase of \$1,028 for Utility (water).

General Fund - Revenue Projection: \$113,001.

- Account 44184 (Photocopy Fees) was increased by \$19,000 due to accident report requests being provided through the NPD instead of through the State of NH.
- Application for FY2019 VAWA Grant: Funding in the amount of \$58,000 and a request for a contingency fund match of \$69,298. The grant is for the salary and benefits for two positions, the Domestic Violence Victim Advocate and the Domestic Violence Officer.

The budget will be submitted to the City by February 9, 2018. A discussion with the Mayor is scheduled for February 14, 2018. The Nashua Police Department is scheduled for the Departmental FY19 Budget Hearing with presentations on Thursday, April 5, 2018, at 7:00 p.m.

MOTION: Motion by Commissioner Tollner, seconded by Commissioner Dahl, to approve the preliminary proposed budget for FY2019 in the amount of \$21,528,331 (for submission purposes to the City). This budget is subject to change due to an upcoming budget meeting with Mayor Donchess on February 14, 2018. All in favor.
