During the past week members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Unit arrested six individuals after an investigation into the sale of Crack Cocaine in the City of Nashua. The Hudson Police Department assisted in the arrest of Jay Gladstone. The arrested individuals were Travis Gladstone, age 22, of 73 Ash Street in Nashua, Jay Gladstone, age 59, of No Fixed Address in Nashua, Dennis Little, age 54 of 79 Ash Street in Nashua, Jennifer Bray, age 46, of 3 Acton Street in Nashua, Emmanuel Infante, age 27, of 16 East Pearl Street in Nashua and Paula Gregoire age 49 of 173 Lowell Road in Hudson.

Travis Gladstone was arrested and charged with;

-Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine, Felony

-Criminal Liability to Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine, Felony (two counts)

-Acts Prohibited, Possession of a Controlled Drug, Crack Cocaine with the intent to distribute, Felony

Travis was held on \$100,000 cash bail.

Jay Gladstone was arrested and charged with;

-Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine, Felony (6 counts)- Second Offense

Jay was held on \$500,000 cash bail. He was currently out on bail, still awaiting trial on two prior drug felony charges that took place in May 2016 in Nashua.

Jennifer Bray was arrested and charged with;

-Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine, Felony

-Acts Prohibited, Possession of a Controlled Drug, Crack Cocaine, Felony

Bray was held on \$500.00 cash bail.

Paula Gregoire was arrested and charged;

-Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine, Felony-Second Offense
