On November 1, 2018, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, Traffic Enforcement Unit, and the Hudson Police Department conducted another operation as part of the Granite Shield program where three individuals were arrested for drug-related crimes. These individuals were:

Stephen Galvin, age 37, of 31 Beverly Avenue, Salem, New Hampshire was charged with Acts Prohibited, Possession of a Controlled Drug, Heroin, Felony, and Driving After Suspension, Misdemeanor. Galvin was released on personal recognizance bail and will be arraigned on November 15, 2018.

David Roy, age 36, of No Fixed Address, Nashua, New Hampshire was charged with Acts Prohibited; Possession of a Controlled Drug, Heroin, Second Offense, Felony, and Acts Prohibited; Sale of a Controlled Drug, Heroin, Second Offense, Felony. Roy was released on personal recognizance bail and will be arraigned on November 15, 2018.

Sabrina Bolton, age 28, of No Fixed Address, Nashua, New Hampshire was charged with Acts Prohibited; Sale of a Controlled Drug, Marijuana, Felony, and an Electronic Bench Warrant out of Hooksett District Court for nonappearance in court with an original charge of domestic violence. Bolton was released on personal recognizance bail, and will be arraigned on December 5, 2018.

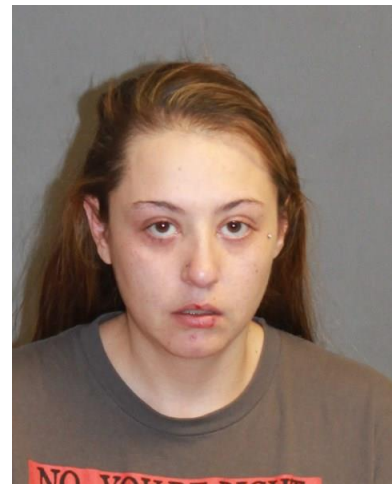
These arrests came at the conclusion of investigations into the distribution of illegal drugs in Nashua and were made possible through funding provided by the Granite Shield program.
