On February 22, 2017 members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, and Traffic Unit conducted a Combined Drug Impact Initiative during which six individuals were arrested for various drug and drug related offenses. These individuals were: Dawn Pyles, Joshua Vieira, Jason Poloski, William McKnight, Kevin Jenkins, and Farrah Vander-Heyden.

Dawn Pyles, age 39, of No Fixed Address, was charged with one count Sale of Controlled Drug, Heroin, Felony and one count Common Nuisance, Felony. Pyles is currently being held on \$50,000 cash bail pending her arraignment on February 23, 2017.

Joshua Vieira, age 32, of No Fixed Address, was charged with two counts Sale of Controlled Drug, Heroin, Felony. Vieira's bail was set at \$50,000 cash bail and he is scheduled to be arraigned on February 23, 2017.

Jason Poloski, age 38, of 17 Temple St., Nashua, N.H., was charged with two counts of Sale of Controlled Drug, Heroin, Second Offense, Felony and Possession Of Controlled Drug, Heroin, Second Offense, Felony. Poloski is currently being held on \$50,000 cash bail pending his arraignment on February 23, 2017.

William McKnight, age 46, of 28 Railroad Square Apartment 12, Nashua, N.H., was charged with two counts of Sale of Controlled Drug, Heroin, Felony. McKnight is currently being held on \$50,000 cash bail pending his arraignment on February 23, 2017.

Kevin Jenkins, age 58, of No Fixed Address, was charged with Possession of Controlled Drug, Heroin, Second Offense, Felony, Possession of Controlled Drug, Marijuana, Misdemeanor, and Falsifying Physical Evidence, Felony. Jenkins is currently being held on \$25,000 bail pending his arraignment on February 23, 2017.

Farrah Vander-Heyden, age 34, of 5 Russell St. Apartment 4, Wilton, NH, was charged with one count of Possession of Controlled Drug, Suboxone, Felony. Vander-Hayden is currently being held on \$10,000 bail pending her arraignment on February 23, 2017.

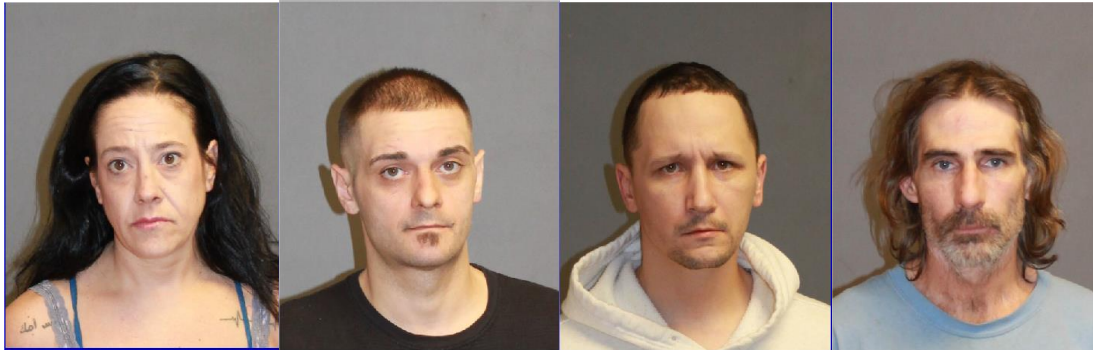

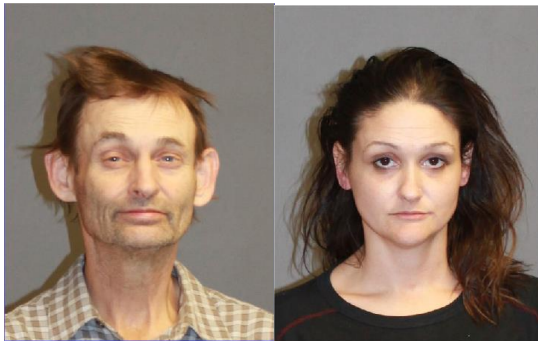

All defendants will be arraigned at the 9th Circuit Nashua District Division Nashua Court. A Felony is punishable by a term of imprisonment at the State Prison, exclusive of fines. A misdemeanor is punishable by up to one year imprisonment at the county jail, exclusive of fines.
