During the week of August 11, 2017, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, and Traffic Unit participated in a combined drug impact initiative where numerous individuals were arrested for various drug crimes and various crimes frequently associated with criminal behavior related to drug activity. These individuals were: Brendon Yoksh, Paul Gianetta, Dakota Gladstone, Brian Poulin, Sean Muldoon, Rachel Nickerson, Nigel Almonte, Gerald Lamphier, Samantha Marchant, Nelson Mercado, Michael Smokler, Shane King, and Andrew Larose.

Brendon Yoksh, age 23, of 70 North Lowell Road, Windham, NH was arrested on August 07, 2017 for an active arrest warrant and was charged with one count of Acts Prohibited; Sale of Controlled Drug, Cocaine, Felony. Yoksh was released on \$30,000 personal recognizances bail and is scheduled for arraignment on October 04, 2017.

Paul Gianetta, age 42, of 11 Atwood Court, Apartment 5, Nashua, NH was arrested on August 07, 2017 and was charged with Possession of Controlled Drug, Heroin, Felony. Gianetta was released on \$300.00 cash bail and is scheduled for arraignment on October 05, 2017.

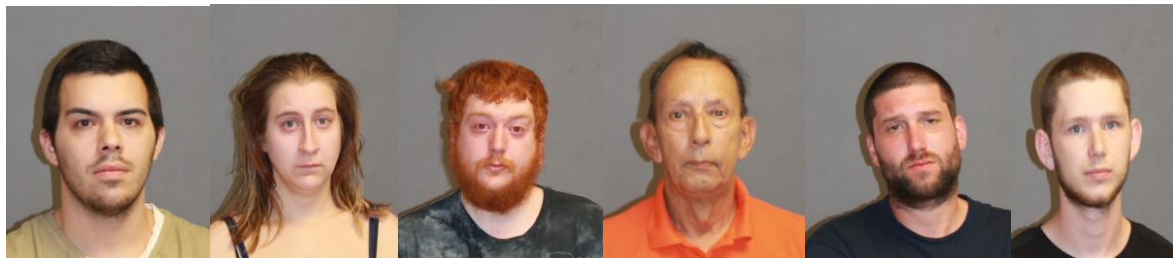

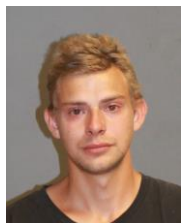
