On March 22nd, 2018, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, and Traffic Enforcement Unit participated in Operation Granite Shield where five individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were Scott Collier, Eddie Nolasco, Joe Burgos, Laura Gettings, and Corey Scruton.

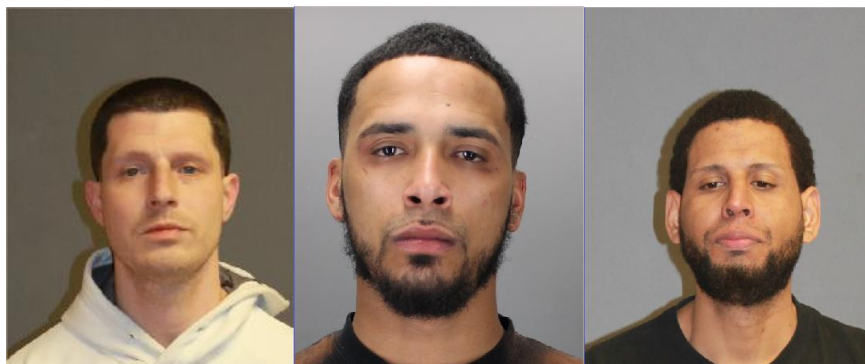
Scott Collier, age 36, of No Fixed Address, Nashua, NH was arrested charged with one count of Acts Prohibited; Possession of a Controlled Drug (2nd Offense), Crack Cocaine, Felony. Collier also had an active Capias arrest warrant. Collier refused bail and is scheduled for arraignment on March 23rd, 2018.

Eddie Nolasco, age 24, of 230 Lincoln Street, Lowell MA was arrested and charged with 2 counts of Acts Prohibited; Sale of a Controlled Drug, Heroin and Oxycodone, Felony. Nolasco was also charged with 2 counts of Resisting Arrest or Detention, Misdemeanor. Nolasco was held on \$25,000 cash bail and is scheduled for arraignment on March 23rd, 2018.

Joe Burgos, age 32, of 113 Temple Street #1, Nashua NH was arrested and charged with 2 counts of Acts Prohibited; Possession of a Controlled Drug (2nd Offense), Heroin and Crack Cocaine, Felony. Burgos was also charged with Falsifying Physical Evidence, Felony. Burgos was held on \$5,000 cash/surety bail and is scheduled for arraignment on March 23rd, 2018.

Laura Gettings, age 27, of 11 Ridge Street, Nashua, NH was arrested on an active Capias warrant. Gettings was held without bail and is scheduled for arraignment on March 23rd, 2018.

Corey Scruton, age 27, of 9 Pleasant Street, Nashua, NH was arrested on an active Capias warrant. Scruton was held without bail and is scheduled for arraignment on March 23rd, 2018.
