On April 11, 2019, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, Traffic Enforcement Unit, and the Hudson Police Department conducted another operation as part of the Granite Shield program where six individuals were arrested for drug-related crimes. These individuals were:

Nicholas Guerrero, age 23, of No Fixed Address, Nashua, New Hampshire was charged with Acts Prohibited, Sale of a Controlled Drug, Heroin, Felony, Theft by Unauthorized Taking, Misdemeanor A, and Theft by Deception, Misdemeanor A. Guerrero was released on personal recognizance bail pending an arraignment on a future date.

Shannen Tocci, age 27, of 33 Elm Street Apartment #2, Goffstown, New Hampshire was charged with Acts Prohibited; Possession of a Controlled Drug, Methamphetamine, Felony. Tocci was released on personal recognizance bail pending an arraignment on a future date.

Jonathan Briere, age 25, of 428 Forest Road, Wilton, New Hampshire was charged with two counts of Acts Prohibited; Sale of a Controlled Drug, Heroin, Second Offense Felony, Acts Prohibited; Possession of a Controlled Drug, Cocaine, Second Offense, Felony, and Falsifying Physical Evidence, Felony. Briere was released on personal recognizance bail pending an arraignment on a future date.

Richard Rowell, age 46, of 5 Burns Hill Rd Apartment 54, Hudson, New Hampshire was charged with Acts Prohibited; Possession of a Controlled Drug, Crack Cocaine, Second Offense, Felony, and two counts of Falsifying Physical Evidence, Felony. Rowell was held on bail and will be arraigned on April 12, 2019.

Andrew Millward, age 66, of 428 Forest Road, Wilton, New Hampshire was charged with Criminal Liability to Acts Prohibited; Sale of a Controlled Drug, Heroin, Felony. Millward was released on personal recognizance bail pending an arraignment on a future date.

Nicole Flanagan, age 18, of 8 Boxwood Circle, Milford, New Hampshire was charged with Acts Prohibited; Sale of a Controlled Drug, Heroin, Felony. Flanagan was released on personal recognizance bail pending an arraignment on a future date.

These arrests came at the conclusion of extensive investigations into the distribution of illegal drugs in Nashua and were made possible through funding provided by the Granite Shield program.

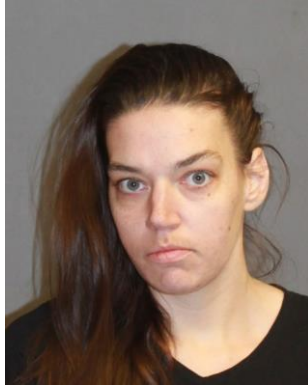

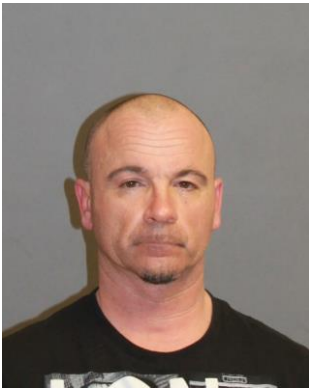

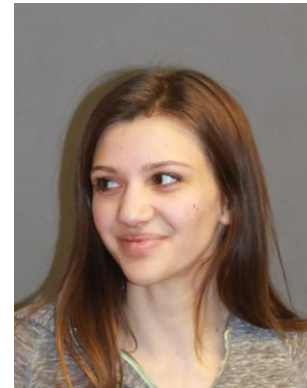
