During the week of February 17, 2017, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Unit participated in Operation Granite Hammer. During this time a number of individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were: Bruce Lee, Jessica Preston, Brian Poulin, Eric Perry, Omar Rodriguez, and Michael Alonzo.

Bruce Lee, age 34, of 10 Bertha Street, Lowell, MA was charged with Sale of Controlled Drug, Oxycodone (two counts). Lee was released on \$10,000 cash bail and is scheduled for arraignment on April 03, 2017.

Jessica Preston, age 39, of 41 Hughey Street, Nashua, NH was charged with one count of Possession of Controlled Drug, Suboxone. Preston was released on \$500.00 cash and is scheduled for arraignment on March 30, 2017.

Brian Poulin, age 38, of 89.5 Palm Street, Nashua NH, was arrested on an out of town warrant for the charge of Possession of Controlled Drug, Cocaine. Poulin was released to the warrant issuing agency (Hollis PD).

Eric Perry, age 21, of 5 Danforth Road Apartment 1, Nashua, NH, was charged with Possession of Controlled Drug, Suboxone. Perry was held on \$10,000 cash or surety bail and is scheduled for arraignment on February 20, 2017.

Omar Rodriguez, age 19, of 40 Cross Street Apartment A, Nashua, NH, was charged with Sale of a Controlled Drug, Heroin and a second count of Sale of Controlled Drug, Crack Cocaine, and Operating Without a Valid License. Rodriguez was held on \$20,000 cash bail and is scheduled for arraignment on February 20, 2017.

Michael Alonzo, age 29, of 29 Tower Hill Street, Lawrence, MA, was charged with Sale of a Controlled, Heroin (3 counts). Alonzo was released on \$10,000 cash or surety bail and is scheduled for arraignment on March 31, 2017.
