During the week of May 29th, 2017, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Unit participated in Operation Granite Hammer. Three individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were: Jocelyn Timmins, Corey Moody and Mario Cameron.

Jocelyn Timmins, age 27, of No Fixed Address, Nashua, NH was charged with one count of Sale of Controlled Drug, Methamphetamine, Felony. Timmins was held on \$25,000 cash bail and is scheduled for arraignment on May 31, 2017.

Corey Moody, age 26, of 37 Ellington Street Apartment 3, Dorchester, MA was charged with one count of Sale of Controlled Drug, Heroin, Felony, one count Sale of Controlled Drug, Crack Cocaine, Felony, one count Possession with Intent to Distribute, Heroin, Felony, one count Possession with Intent to Distribute, Crack Cocaine, Felony, and one count Possession with Intent to Distribute, Suboxone, Felony. Moody possessed approximately 19 grams of heroin, 10 grams of crack cocaine and 28 sublingual Suboxone strips. Moody was held on \$200,000 cash bail and is scheduled for arraignment on May 31, 2017.

Mario Cameron, age 33, of 275 Webster Street, Hudson, NH was charged with two counts Sale of Controlled Drug, Cocaine, Second Offense, Felony. Cameron was held on \$75,000 cash bail and is scheduled for arraignment on June 1, 2017.
