On January 27, 2017 members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Enforcement Unit conducted another operation as part of the Granite Hammer Operation where 14 individuals were arrested for drug-related crimes. These individuals were:

Jennifer Ives, age 35, of 434 Barnstead Rd in Barnstead, NH, was charged with one count of Acts Prohibited, Sale of a Controlled Drug, Heroin. Ives sold approximately 5 grams of Heroin and was held on \$25,000 cash bail.

Michael Briand, age 25, of No Fixed address, in Nashua was charged with one count of Acts Prohibited, Sale of a Controlled Drug, Heroin. Briand refused bail.

Candi Goodwin, age 34, of 48 Mckean St Apt B, in Nashua was charged with one count of Unlawful Possession of Prescription Drugs. Goodwin was held on \$240 cash bail.

Heather Brunelle, age 46, of 14 Pratt St, in Nashua was charged with Unlawful Possession of Prescription Drugs-Oxycodone. Brunelle was released on \$500 cash bail.

Kelly Winans, age 29, of 18 Beechwood Rd, in Hudson was charged with Possession of a Controlled Drug-Marijuana. Winans was released on \$2,000 Personal Recognizance.

Theresa Bissonnette, age 36, of 6 Strawberry Bank Rd Apt 20, in Nashua was charged with one count of Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine. Bissonnette was held on \$2,500 Cash or Surety.

Thomas Flaherty, age 27, of 37 Manchester St Apt B, in Nashua was charged with one count of Unlawful Possession of Prescription Drugs-Oxycodone Hydrochloride. Flaherty was held on \$200 cash bail.

Eugene Robinson, age 49, of 30 Wilder St, in Nashua was charged with Unlawful Possession of Prescription Drugs-Oxycodone Hydrochloride. Robinson was released on \$5,000 cash or surety bail.

Angel Encarnacion, age 31, of 5 Charles St Apt B, in Nashua was charged with one count of Unlawful Possession of Prescription Drugs-Lorazepam and one count of Unlawful Possession of Prescription Drugs-Gabapentin. Encarnacion was released on \$10,000 cash or surety bail.

Dewayne Perkins, age 25, of 96 Central St, in Leominster, MA, was charged with four counts of Acts Prohibited, Sale of a Controlled Drug, Crack Cocaine and one count of Possession with Intent to Distribute-Crack Cocaine. Perkins was in possession of approximately 16 grams of Crack Cocaine and was held on \$100,000 cash only bail.

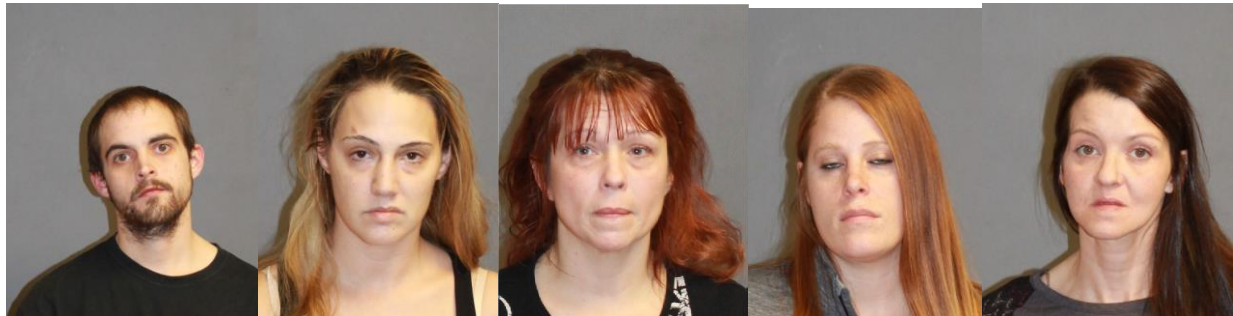
