During the week of April 13, 2017, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Unit participated in Operation Granite Hammer. During this time a number of individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were: Doris Berry, Linda Rancourt, Dustin Gagnon, Erin Buckland, Amber Barton, Crystal Barton, Hadley Jones, Adam Sundstrom, Jill Lapierre, Priscilla Matos, Travis Deluca, and Leah Landino.

Doris Berry, age 48, of 120 Palm Street, Apartment 2, Nashua, NH, was charged with Falsifying Physical Evidence, Felony. Berry was held on \$25,000 personal recognizance bail and is scheduled for arraignment on May 26, 2017.

Linda Rancourt, age 47, of 77 Spit Brook Road, Apartment 220, Nashua, NH was charged with Possession of Controlled Drug, Heroin, Felony. Rancourt was held on \$5,000 cash or surety bail and was scheduled for arraignment on April 11, 2017.

Dustin Gagnon, age 29, of 10 Blossom Street, Nashua, NH was charged with one count of Possession of Controlled Drug, Fentanyl, Felony and also for an outstanding Capias. Gagnon refused bail and was scheduled for arraignment on April 12, 2017.

Erin Buckland, age 40, of No Fixed Address, was arrested for Possession of Prescription Drugs, misdemeanor and on two outstanding Electronic Bench Warrants. Buckland was released on \$137.00 personal recognizance and is scheduled for arraignment on May 31, 2017.

Amber Barton, age 18, of 6 Waterville Drive, Merrimack, NH, was charged with Prostitution Misdemeanor. Barton was released on \$160.00 cash bail and is scheduled for arraignment on May 31, 2017.

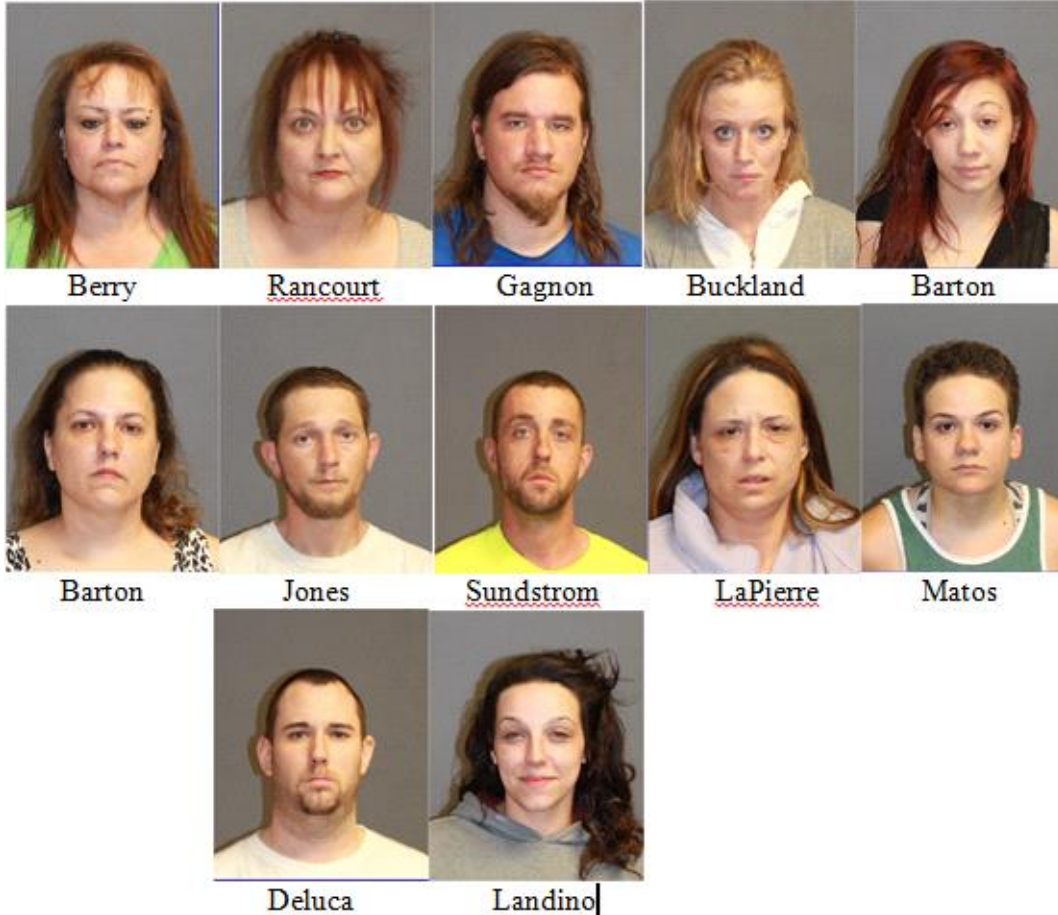
