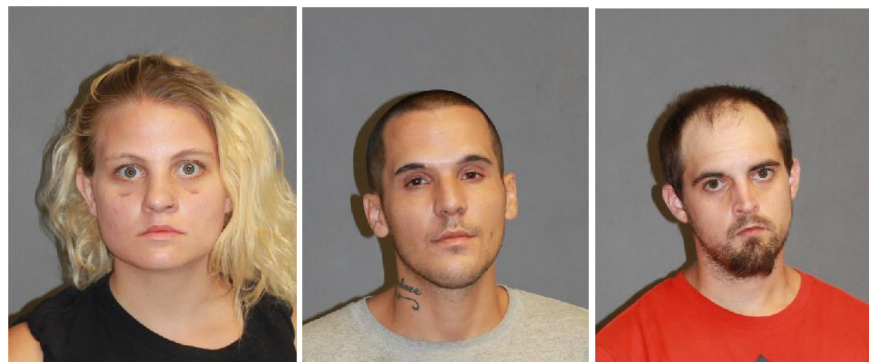
On August 27<sup>th</sup>, 2019 members of the Nashua Police Department's Narcotics Intelligence Division and Problem Oriented Policing Unit were conducting drug enforcement surveillance in a parking lot of a Nashua area business. This location was known to Officers as being frequently used by individuals to conduct drug transactions. While conducting surveillance Detectives observed an interaction consistent with a street level drug transaction and this information was relayed to members of the Problem Oriented Policing Unit.

Officers subsequently made contact with Megan Judd, 25, of 94 White Rock Hill Road, Bow New Hampshire. Based upon information obtained, Judd was arrested and charged with Acts Prohibited; Sale of a Controlled Drug (Heroin) Felony, and Acts Prohibited; Possession of a Controlled Drug (Heroin) Felony.

Officers also made contact with Travis Dunn, 29, of 45 Horse Corner Road, Chichester, New Hampshire. Based upon information obtained, Dunn was charged with Acts Prohibited; Possession of a Controlled Drug (Heroin), Felony, 2<sup>nd</sup> Offense, and Criminal Liability to Conduct of Another- Acts Prohibited; Sale of a Controlled Drug (Heroin), Felony.

Officers also made contact with Michael Briand, 28, of 94 White Rock Hill Road Bow, NH. Based upon information obtained, Briand was charged with Acts Prohibited; Possession of a Controlled Drug (Methamphetamine), Felony, 2<sup>nd</sup> Offense, and Criminal Liability to Conduct of Another- Acts Prohibited; Sale of a Controlled Drug (Heroin), Felony.

Judd, Dunn, and Briand were all released on bail and are scheduled to be arraigned at a later date.
