During the week of June 26, 2017, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, and Traffic Unit participated in Operation Granite Hammer. Numerous individuals were arrested for various drug crimes and various crimes frequently associated with criminal behavior related to drug activity. These individuals were: Karl Saunders, Sammy Hernandez, Michael Brooks, Kyle Fleury, Tyler Coco, John Pennell, and Ryan Mathews.

Karl Saunders, age 34, of 42 Yarmouth Drive, Nashua, NH was arrested for Conspiracy to Acts Prohibited, Sale of a Controlled Drug, Heroin, Felony.

Sammy Hernandez, age 33, of 246 Main Street Apartment 4, Manchester, NH was arrested for Acts Prohibited, Sale of Controlled Drug, Methamphetamine, Felony and an Electronic Bench Warrant for Non-Appearance in Court.

Michael Brooks, age 61, of 2129 White Mountain Highway, North Conway, NH was arrested for Acts Prohibited, Possession of Controlled Drug, Methamphetamine, Felony and Criminal Liability to Sale of Controlled Drug, Methamphetamine, Felony.

Kyle Fleury, age 26, of 30 Front Street Apartment 604, Nashua, NH was arrested for Criminal Liability, Sale of Controlled Drug Methamphetamine, Felony.

Ryan Mathews, age 30, of 10 Anna Circle, Derry, NH, was arrest for four counts of Possession of Prescription Drugs, Misdemeanor after being found in possession of Cenfore-100, Vyvanse, Hydroxyzine Pamoate, and Meloxicam.

Tyler Coco, age 23, of 39 Beaver Lake Ave, Derry, NH, was arrested on an Electronic Bench Warrant for Non-Appearance in Court stemming from original charges of Sale, Transportation and Manufacturing of Controlled Drug.

John Pennell, age 31, of 36 Brady Circle, Manchester, NH, was arrested on a Capias warrant stemming from original charges of Possession of Narcotic and Controlled Drugs.

These individuals were all held on bail and will be arraigned June 28, 2017.

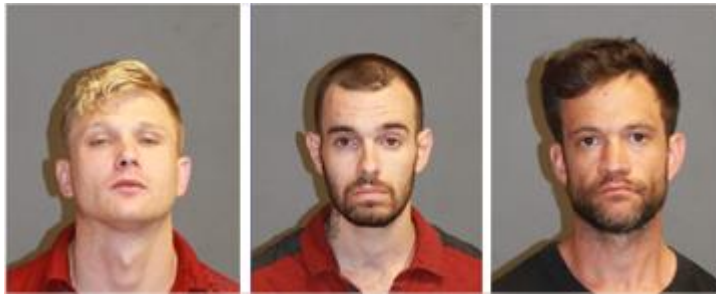
