February 15<sup>th</sup>, 2018, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit, Traffic Unit, Criminal Investigation Division, Special Investigations Division, and Patrol Division, along with members of the Drug Enforcement Administration and FBI Safe Streets Task Force participated in Operation Granite Shield. Throughout the day of February 15<sup>th</sup>, 29 people were arrested. 20 people were arrested for drug offenses and crimes associated with drugs, and 9 people were arrested for unrelated crimes.

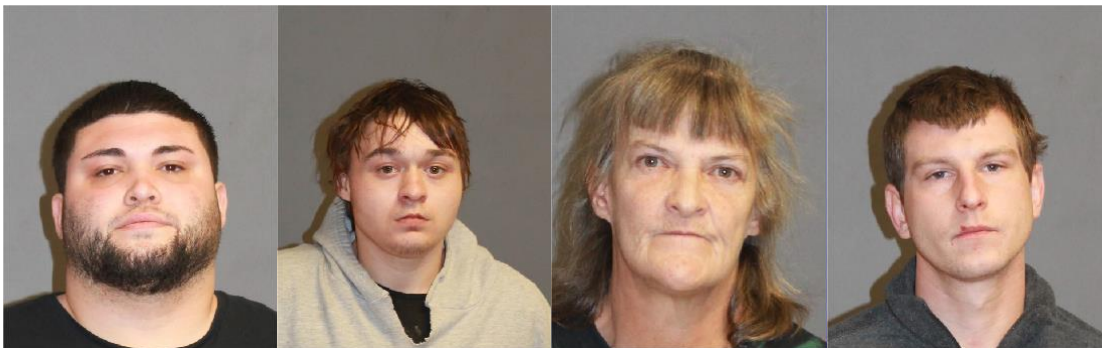

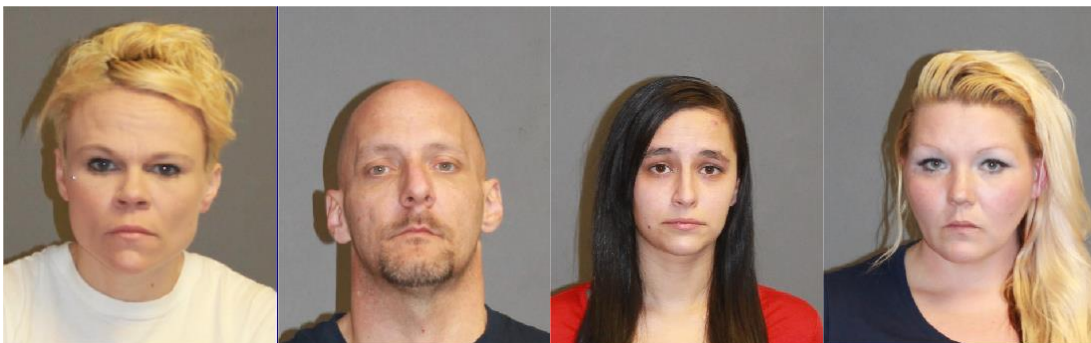

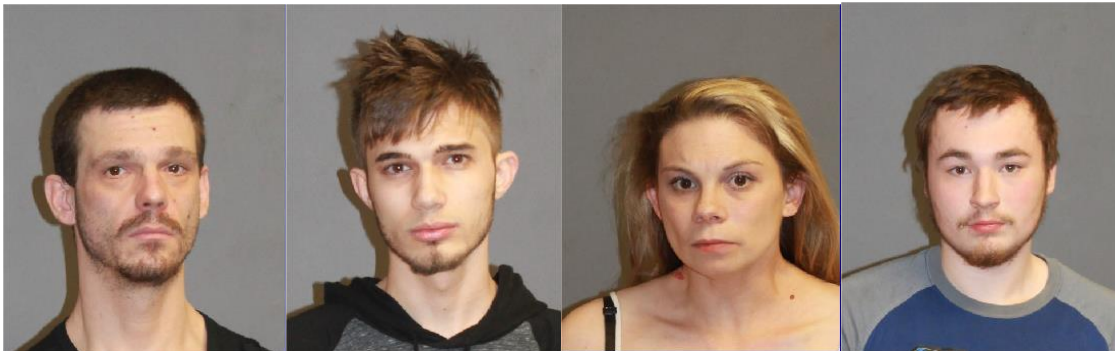
