On August 21 2017, the Nashua Police Departments Traffic Enforcement Unit and Problem Oriented Policing Unit arrested three individuals as a result of an investigation that was conducted by the Nashua Police Departments Narcotics Intelligence Division and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) into the possession, sale and distribution of firearms and narcotics in the City of Nashua. As a result of this investigation the following individuals were arrested and charged;

Anthony Farmer age 24 of 121 Hanover Street, Manchester, New Hampshire was arrested and charged with Armed Robbery (Handgun), Possession of a Controlled Drug with the Intent to Distribute Cocaine (approximately 48 Grams), Acts Prohibited. Possession of a Controlled Drug with the Intent to Distribute Crack Cocaine (approximately 29 Grams), Acts Prohibited Possession of a Controlled Drug with the Intent to Distribute Marijuana (233 grams), and Felon in Possession of a Dangerous Weapon (Handgun). Farmer was arraigned on August 22, 2017 and is being held on \$1,000,000 cash or surety bail.

Aaron Sperow age 25 of 8 Abbott Street, Nashua, New Hampshire was arrested and charged with Armed Robbery (Handgun) and Felon in Possession of a Dangerous Weapon (Handgun). Sperow was arraigned on August 22, 2017 and is being held on \$500,000 cash or surety bail.

Raymond Perez, age 18 of 26 Eleventh Street, Nashua, New Hampshire was arrested and charged with Armed Robbery. Perez was arraigned on August 22, 2017 and is being held on \$250,000 cash or surety bail.

Following the defendants arrest two firearms, crack cocaine, cocaine, marijuana and United States Currency were seized as evidence.
