On January 26, 2018, members of the Nashua Police Department's Narcotics Intelligence Division, Problem Oriented Policing Unit and Traffic Enforcement Unit conducted another operation as part of the Granite Shield program where four individuals were arrested for drug-related crimes. These individuals were:

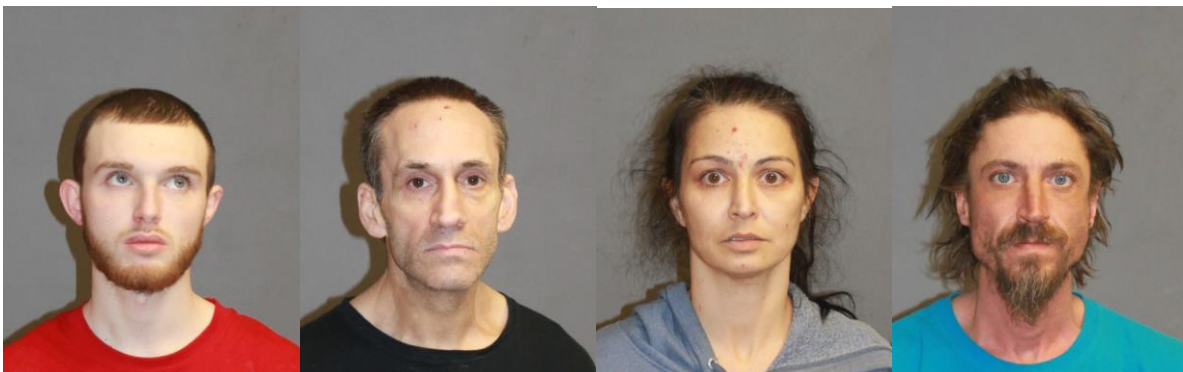
Joshua Cook, age 20, of 62 Hickory Street, Manchester, NH was charged with one count of Acts Prohibited, Possession of a Controlled Drug, Heroin, Felony, Possession of a Controlled Drug, Marijuana, Violation, and Operating After Suspension, Violation. Cook was held on \$5,000 cash or surety bail and is scheduled to be arraigned on January 29, 2018.

Bret Cooper, age 50, of 18 Canal Street #6, Nashua, NH was charged with one count of Common Nuisances, Felony. Cooper is facing this charge due to controlling a residence which was resorted to by drug-dependent persons for the purpose of using controlled drugs or which was used for the illegal keeping or selling of the controlled drugs. Cooper was held on \$5,000 cash or surety bail and is scheduled to be arraigned on January 29, 2018.

Shannon Presutti, age 39, of No Fixed Address, was charged with a Capias Warrant for Failure to Appear on the original charge of Acts Prohibited, Felony. Presutti was held without bail and is scheduled to be arraigned on January 29, 2018.

Matthew Belanger, age 43, of 193 East Dunstable Road Nashua, NH was charged with Acts Prohibited, Possession of a Controlled Drug, Crack Cocaine, Felony. Belanger was held on \$5,000 cash or surety bail and is scheduled to be arraigned on January 29, 2018.

These arrests came at the conclusion of extensive investigations into the distribution of illegal drugs in Nashua and were made possible through funding provided by the Granite Shield program.
